- Still evaluating interest for the older kids, recruitment has been a little disorganized so not sure what interest is. Maybe we pay the TechLX team to do the robotics for the 4-8 graders or look at other parents to possibly lead.
- MV code was delayed because they didn't have the personnel to provide support.
  Maureen was coordinating the room, etc.

## Finances and Enrollment

- 3 above budget
- Two other students were not prepared to work at their grade level, were advised to go back to public school and use the resources available there. Report cards, etc. did not indicate their readiness. Didn't identify
- We need services for students with learning disabilities to increase for the 6-8 grades. In general are we not paying enough attention to the middle school level children. Too much focus on early childhood education.
- Financially in a good place
- FACTS roll out
  - Not consistency among how teachers are using and posting materials, or uncertainty on how to use it.
  - Will get direction from FACTS staff and then try to development consistency.
  - Continuing issues with pizza purchasing
