# **Executive Director's Report**

Jenna Lorge presented updates about enrollment status, park day kickoff, parent engagement opportunities, and the schoolwide testing goal of increasing by 2%. Jenna also presented the highlights of the testing toolkit, teacher professional development topics, and the staff new hires.

# Discussion and Potential Action on the September Financials with July, August, and September Check Registers

Jason Sitomer from Charter Impact presented the September financial package. Average Daily Attendance (ADA) increased to 4781, which is 12% above the budgeted amount. This caused the revenue and expenses to increase. The projected fund balance is 5% over the state requirement.

# Discussion and Potential Action on the Resolution to Recognize the Legal Extension of the Charter Term

Dr. Erika Vanderspek presented the resolution that documents the changes to Education Code 47607.4, which extends Cabrillo Point Academy's charter term to expire June 30, 2027. Devon Roseli made a motion to approve. Bryce Korngold seconded. Unanimous.
