Caroline Moon motioned to approve the CAC Representative. Sherry McFadden seconded.

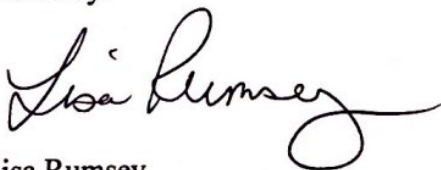
**Adjournment:**
