#### **Senior Director's Report**

- a. Turkey Trot was a success. Over 100 attendees. Coffee and Conversations great turnout.
- b. More Cabrillo Community Upcoming Events announced.
- c. Rollover Planning Amounts SB 98 (2020) School will not rollover any 2020-2021 planning amount funds for use in the next school year.
- d. Covid-19 Update Orange County has moved to purple tier this week. Enrichment services have moved back to virtual. Riverside, San Diego, and Imperial Counties remain in purple tier. School events, teacher meetings, and teacher created fieldtrips will continue to be virtual.
  - Sherri McFadden asked why local schools are remaining in person and ours isn't. Jenna replied that the guidance is not clear for non-classroom-based charters and the use of educational vendors. See item e. below. Natasha Brunstetter asked about what happens to students that are paying monthly fees. Jenna replied that those services won't be cancelled. Most are willing to switch to virtual.
- e. In-person services update: working with legal to develop a plan to allow in-person services while in purple tier.
- f. 2020-2021 began annual Dehesa Oversight Process with 6 areas of focus. First upload of requested documentation is due December 11, 2020.
- g. Staff update: one new Enrichment Specialist.
