Public comment rules: Members of the public may address the Board on agenda or non-agenda items through the teleconference platform, zoom. Speakers may be called in the order that requests are received. If the board utilizes simultaneous translation equipment in a manner that allows the board to hear the translated public testimony simultaneously, those individuals are allotted 2 minutes each.
