## **New Business**

2. Discuss and adopt the FY26 Final Budget.

Executive Director, Amber Robinson, shared that the budget has been updated using the newly released forms from the auditor general's office. The key difference was adding the one time state aid (estimated based on percentage of students) and the per pupil was slightly higher than in the preliminary budget. No questions were raised.

Becki Krueger motioned to approve and adopt the FY26 budget that was presented. Lauren Gray seconded the motion.

The motion to approve and adopt the FY26 budget was approved 4-0.

3. Discuss and potentially vote on adding an assistant principal.

The Executive Director shared the need to add on an assistant principal that would focus on K-5 and intervention, while the Executive Director/Principal would oversee 6-12th and Special Education. The board discussed how this could better support teachers, students, and the parents more. In order to stay in line with the current budget, the Executive Director's salary will be reduced by \$25,000. This will allow a salary increase to promote a staff member to Assistant Principal.

Mark Earle motioned to approve the addition of an assistant principal and update the salaries of the administration team. Andrea Biery seconded the motion.

Roll call vote to approve the addition of the assistant principal and update salaries to reflect the addition.

The motion to approve the addition of an assistant principal and update the salaries was approved 4-0.
